Abstract



The COVID-19 has massively affected educational institutions around the world. Among these institutions are private educational institutions, including private tutoring institutes (PTIs). While there has been studies on the impacts of the COVID-19 pandemic on different educational institutions, research on that in the PTI sector remains scant. With this in mind, the current study investigates the impacts of the COVID-19 pandemic on the private tutoring sector. A local case in Indonesia was selected to explore the responses of private tutoring stakeholders and educators. Implications for curriculum development, workforce planning, and basic measures for private tutoring directors and educators are addressed. This study attempts to draw attention to the importance of private tutoring amid such emergencies.

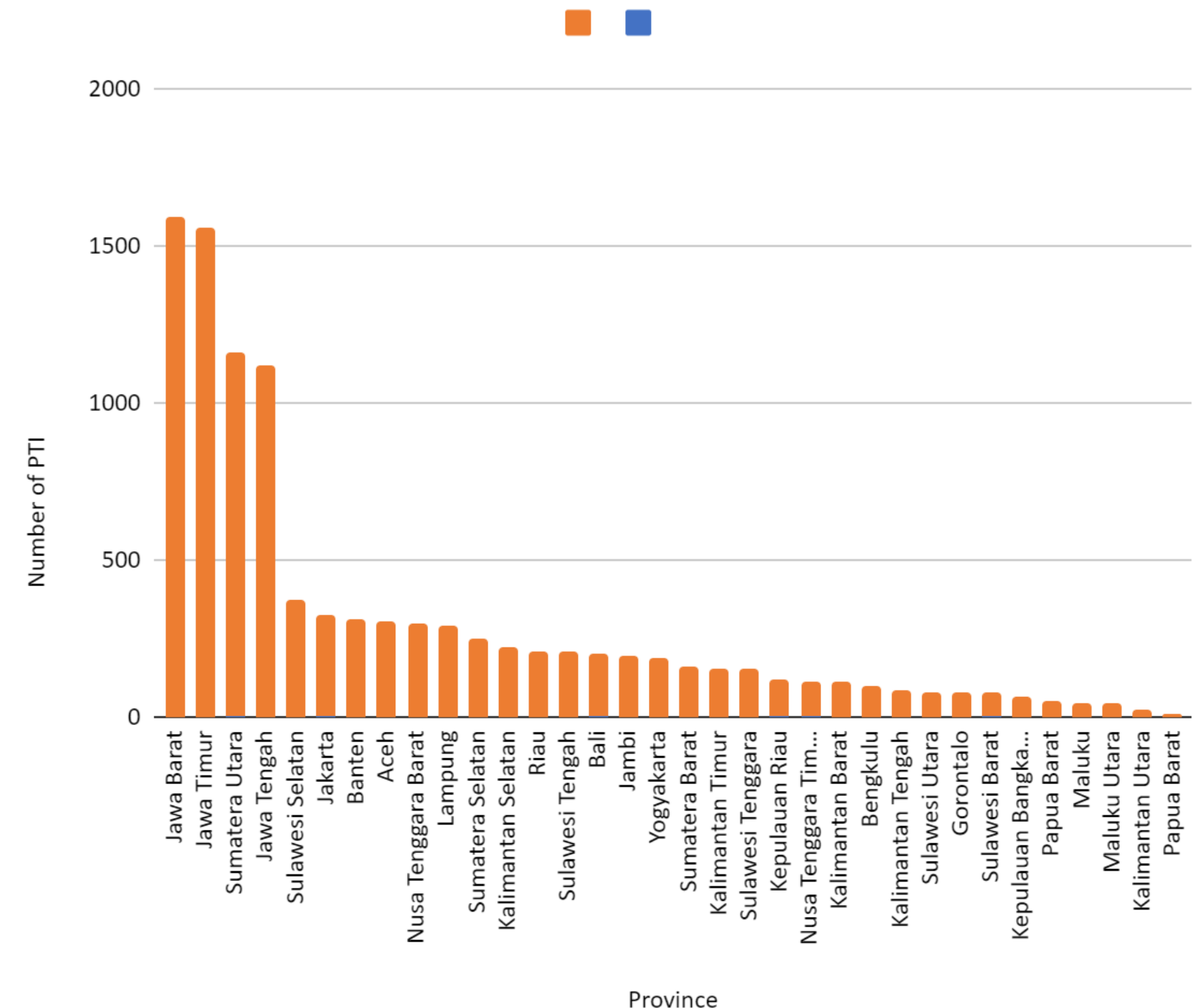

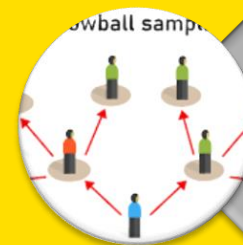
Research Design and Participants of the Study

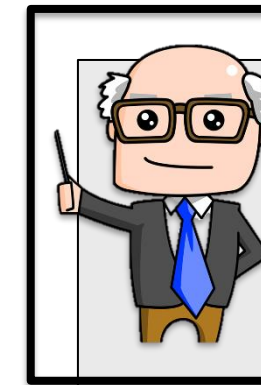

Institutional Impact: Director's Viewpoint (2/2)

Key Findings from the Study:

The Significant Decrease of Enrolled Students

Before pandemic: Up to 3,500 students; During pandemic: 1,500 students at top.

(A significant decrease of 57% within the first 2-3 months of the pandemic)

The Adjusted number of employees due to Financial Crisis

A total of 18 staff including tutors (37%) were laid off due to financial instability.

Following the government recommendations, all the tutors are working from home.

The Imposed Emergency Policy for Sustainability

At the institutional level, some emergency policies were applied including:

An adjustment to the tutoring format, Tutor's Supervision & Training, Marketing Strategy, etc.

Key Findings from the Study:

Transitioning to Online Language Learning and Teaching

At the initial migration to online learning, some issues emerged both from students and the tutors with **the device and poor internet connection** being the most significantly reported.

Fulfilling the Student's and Parent's Expectations

The students and their parents expect the online learning to be as effective and as interactive as direct face-to-face learning since **they pay the same amount of money for each session.**

Calling for Sufficient Supports for Learning and Teaching

In attempt to fulfil such expectations, the tutors call for supports from the institution including **the adjusted lesson procedures, regular tutors trainings, and free top up for their internet bills.**
