Abstract

Of all regions on this earth, not all of them are inhabited by Muslim-majority communities, but more non-Muslim-majority communities. So this study aims to see the status and understanding of the prophet's hadith about the prohibition of living in non-Muslim communities in the present context. This prohibition does not apply if the non-Muslim country is safe, there is no difficulty in worshipping and fulfilling obligations as a Muslim, and can show the identity and lifestyle of a Muslim.

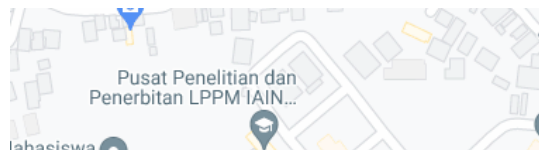
