UTILIZING QUILLBOT PARAPHRASER TO MINIMIZE PLAGIARISM INSTUDENTS' SCIENTIFIC WRITING

However, its significance cannot be separated from the fact that writing is one of the most difficult components of language competency. Moreover, the issue of plagiarism in writing remains atrending topic, as its existence is harmful to a writer whose work is copied without proper citation. In this instance, both lecturers and researchers identify instances of plagiarism in student writing (Choi, 2012). Some people, especially internet-based people, are careless with their copy-paste work. According to Al Hassan & Ahmed (2019). the culture of copying and pasting seems to have become common knowledge among students. Another survey indicated that word-for-word plagiarism is thetop challenge lecturers faced while teaching writing (Hayuningrum, 2021). Therefore, lecturers put a lot of effort into devising strategies to prevent their students from engaging in plagiarism (Choi, 2012). Typically, students are assigned scientific articles as part of their coursework. The objective of scientific endeavour is to resolve an existing problem. The scientific effort must include data, facts, and solutions to the posed challenges. Therefore, when creating scientific papers, students must adhere to the essential components of the standards for writing scientific papers, including the use of formal, standard language, in accordance with theory and field-specific facts. Papers, theses, reports, and dissertations are examples of popular scientific writing types. Additionally, they must know the proper

citations and systematics.

Whether they are writing a scientific article or a personal essay, students may need aid rephrasing their subject or expressing themselves in a different way. They could perform it manually to obtain a higher quality standard, but if they're stressed for time, a tool can aid them. Not only may paraphrase tools help us improve our overall writing tone and reduce duplication, but they can also help us avoid plagiarism, which is crucial if we wish to reuse the same information online. Writing English using the technique of paraphrasing is an alternative way to communicate the same topic in the students' words (Ariyanti & Anam, 2021) .

According to Basori (2017), plagiarism has become one of the most important problems in society, particularly in institutions. There are various reasons why people plagiarise, including laziness, a lack of time, a hectic schedule, and the desire to find an easy solution without having to rack our brains and sweat.

There are various techniques for avoiding plagiarism. One of them is the use of paraphrase techniques. Paraphrasing ability is vital in academic tasks such as essay writing, text editing, and summarising, According to Mabbett (2016), paraphrasing what someone else has said is not an exercisein expressing our thoughts. A paraphrase is the process of reconstructing an idea from another source using one's own words and style (Arun et al., 2019). According to Thadphoothon (2019), paraphrase isputting a text or passage's meaning into our own words. As a result, the substance of the source text is preserved. However, he/she did not use the same terminology or style as the source material. Paraphrasing without proper citation is also considered plagiarism. If we steal someone else's idea and express it in our own words and style, we must incorporate correct information about the source in ourwork. This not only provides accurate information about the original text, but it also preserves the notion and meaning of the source text. The skill to paraphrase allows a person to avoid plagiarism (Madani & Ardianti, 2021).

Students working on their final project or thesis often do their own paraphrasing as part of their work. Because it's a requirement of the thesis that none of the content can be copied from elsewhere. One way to paraphrase for free or to get paid is to do it online. There are many websites that will rewritesomething for you for free. But only a few of them work well and are easy to understand. Quillbot is an online paraphrasers include both premium (paid) and free. QuillBot is an artificial intelligence (AI) programme that makes it relatively simple for many individuals to paraphrase. The re-expression of an utterance from one level or kind of language into another speech without affecting the meaning is known as paraphrasing. To avoid plagiarism, this is done. This is a method for avoidingplagiarism (Bairagi & Munot, 2019). Lina and Supriyono (2021) agree that the paraphrasing strategy is

critical for students and is required to lower the percentage of plagiarism check findings.

A number of prior research on paraphrase have been conducted. First, according to Inayah (2012), the study stated that students mechanical engineering vocational education revealed thap paraphrasing online tools help them a lot in doing their works in making dialogue. The use of paraphrase techniques in theatrical scripts, according to Juniastuti (2014), can help students at IX D SMP Negeri 5 Amlapura create better short stories, as evidenced by an improvement in their short story writing's average score. Third, according to Usman (2015), the paraphrasing technique can improve the second-grade students' proficiency in converting poetry into prose at SMP AlIttihat Pekanbaru. Fourth, according to Waningyun et al. (2018), using a paraphrase strategy can improve a writer's ability to craft a short tale. The improvement in writing ability was 76% for the first cycle, 70% for the first cycle, and 80% for the second cycle

This research shares similarities with the earlier studies mentioned above, such as the use of the manual paraphrasing technique or method. Meanwhile, it is about how students can use an online tool called QuillBot Rephraser to avoid plagiarism when citing or writing scientific papers. 3) A formal writing style that is appropriate for writing in a professional or academic setting. With this approach, we adapt our work for a formal audience. It delivers the text in a more refined and expert manner. 4) Simple mode improves the readability and accessibility of our writing. The language is significantly altered in this mode, taking on a whole different look and feel. It provides the content in a style that is understandable to most readers. 5) The creative mode concentrates on altering the text as much as possible in order to produce text that differs from the original. It uses a new language to express ideas, which could alter their intended meaning. While Creative+ is an upgraded form of Creative Mode AI that makes changes more understandable and better recognizes specific items like phrases and frequent talks. 6) Expand mode. In order to enhance the word count, this mode tries to insert as many words as it can. It lengthens sentences by adding extra information and nuance. 7) Shorten mode reduces the length of our material; this option is useful because "Short Mode" does not distort the content's meaning. It pares down the message to the essentials to deliver it clearly.

Method

This study employed a qualitative nature since it examines data that are expressed in words, images, or other visuals and artefacts rather than in numerical or statistical form (Ary et al., 2018), even if it is largely descriptive and centred on examining how the application is used. tool QuillBot.. In order to prevent plagiarism, the researcher wants to describe how QuillBot might be used in english writing.

QuillBot is a data collectionapp. This analyst is evaluating QuillBot's functionality in rephrasing academic papers. This study involves the investigation of a simulated online paraphrasing tool called QuillBot, which is used to rephrase the text. In this study, the researcher plucked a few words (about the definition of paraphrasing) from several literature. Paraphrasing can mean many things depending on who you ask;

definitions can be found in Wette (2020), Hogan (2012), and Harris (2017). The study involves the researcher pretending to utilize QuillBot Paraphraser to reword paraphrasing theory's definitions.

The data in this study were analysed using three methods of qualitative analysis: reducing data, showing data, and drawing conclusions (Miles et al., 2013; Miles & Huberman, 1994). At the data display stage, the researcher draws conclusions that are supported by substantial evidence.

Results and Discussion

The purpose of this study is to recreate, as closely as possible, the process of using QuillBot Paraphraser to rephrase the scientific work of students in order to prevent plagiarism. As demonstrated in the following example, the perspective of the QuillBot Premium edition is as follows:

The phrase that has been effectively paraphrased from the preceding sentence is the one that is underlined. Click the Copy icon to begin copying the phrase. The following is a simulation of the QuillBot Paraphraser being used to rephrase or paraphrase the texts, which may be seen in the tables below.

According to the first sentence that was presented, it demonstrates that QuillBot would rephrase or paraphrase an original text by employing a number of different modes, such as Standard, Formal, Fluency, Creative and Creative+, Formal, Shorten, and Expand. "Education is one of the important pillars that must be held in order to educate the nation's life," states the original text. These styles resemble strategies for paraphrase. There is a rearrangement of words, phrases, or clauses in the modes. Standard mode reliably rewrites text to preserve meaning, fluency mode makes sure text is readable and error-free, and formal mode presents the material in a more refined and formal manner. Additionally, the Standard, Formal, Fluency, and Simple Modes all use synonyms that are close to thosein the original text. the word "important" is changed to "crucial", "essential" and "fundamental" with similar meanings.

The sentence structure is rephrased in these modes by switching from passive to active voice and vice versa, which is a form of the paraphrasing approach. For instance, the line "must be held" in the original text is rephrased as "can do for" in the creative version. The text is rewritten in a reliable manner to preserve its meaning when in standard mode; when in fluency mode, the content isguaranteed to be readable and error-free; and when in formal mode, the material is presented in a manner that is more refined and professional.

The simple mode improves the readability and accessibility of the writing. The text is presented in creative form in a way that most people can grasp. The creative mode communicates concepts in novel ways that may alter their significance. Expand mode increases sentence length by adding additional detail and depth. Shorten mode removes unnecessary words to offer a concise message. These styles of Simple, Creative, Expand, and Shorten paraphrasing employ the strategy of word synonyms (words or phrases with the same meaning) and switching the sentence structure from active passive voice and vice versa.

Formal, Fluency, Creative, Expand, and Shorten. The use of synonyms is used where the original, Fluency and Formal modes are comparable to one another. For example, in the original text, the term "technique" is rephrased into "method", the term "students" is rephrased into "pupils" to demonstrate a similar meaning. The writing is easier to read and understand when it is in simple mode. The term "topic" is rephrased similarly to be "subject" in Standard and Creative mode, while it is rephrased differently in Formal into "issue", and "concept" in Shorten mode. Simple, Expand Mode into "further, additionally, as a benefit, this further." The text is shown in a way that most people can understand in creative mode. Creative mode lets ideas come out in a totally new way that could change

what it implies. The expand mode adds more depth and detail to a sentence to make it longer. While inShorten mode, extra words are picked out to make the message clear.

Discussion

QuillBot is a free online tool for rephrasing text. It has five modes for making new text: fluency, standard, suggestive, creative, and consistent. For instance, we may aim to enhance the content by using additional synonyms to spice it up and make it more distinct. Instead of repeatedly using the same phrases, QuillBot will automatically substitute alternative terms and rephrase some sentences. In addition, it will offer additional paraphrase options that are not automatically inacluded but can be added with the click of a button. This tool's best feature is that it paraphrases the sequence of sentences as well as the words. Avoiding plagiarism is an advantage of paraphrasing in written work.

Plagiarism is the transfer of a portion or the entirety of a text without citing the source. The process of paraphrasing shortens lengthy statements. According to the context of the scientific work being created, we do not duplicate the entire paragraphs' text, but only the primary concept.

The paragraphs are difficult to access and simple to digest. Rewriting, summarising, and condensing the language increases the readability of our writing. According to Adams and Chuah (2022), investigations investigate the effectiveness and utility of QuillBot for writers and researchers.

Based on the findings, this research result is consistent with Sarair (2019) assertion that writingin English using the technique of paraphrasing is an alternative that uses the students' language to express the same idea. In addition to making concepts easier to comprehend, writers can employ paraphrase to retain coherence and consistency in the flow of their writing.

Teaching students how to paraphrase is a challenging task, not only for students but also for lecturers. It is a level of complexity beyond and above the mastery of grammar, vocabulary, and even writing (Inayah & Sulistyaningrum, 2021). Therefore, they should modify and improve their teaching and learning methods in order to minimise linguistic barriers. In addition, students often have a lowerlevel of English comprehension since they engage in more practical than theoretical tasks. According to Lawelai et al. (2022), a student must possess great paraphrasing skills. However, students have not properly studied the paraphrasing method. This ability can be enhanced through the use of free or commercial online programmes.

Additionally, paraphrase might involve merging word equations or synonyms as well as changing the word order of a sentence.

- 4. Using active or passive sentences to rephrase. Sentences including subjects, verbs, and objects can be transformed into active or passive sentences, or vice versa.
