#### Notes:

- 1. Each student presents their dissertation proposal in 10-15 minutes.
- 2. Each student prepares a Power Point up to 10 slides (7-8 is ideal).
- 3. After the presentation, each of the examiners is given about 15 minutes to give feedback/ask questions.
- 4. Examiners must finalize the score before the next student's presentation. The aim of checking collective grading is to avoid too large a gap of score among the examiners. The maximum score gap among examiners is 10 points. The chair should ensure that all examiners' grades are finalized before moving to another student's seminar.
- 5. Students are declared to have passed the dissertation proposal examination if they obtain an average score from all examiners of at least 70.
